Cochrane South Africa Outputs

1 April 2018 - 31 March 2019

HIGHLIGHTS

Cochrane South Africa (SA) hosted the 3rd African Cochrane Indaba in Cape Town on 25-26 March 2019. The theme of the conference was 'trusted evidence for better health decisions in Africa'. It was attended by 109 delegates from 17 countries of which 12 were African countries. The programme consisted of 4 plenaries, 51 poster presentations, seven workshops and one panel discussion. Feedback received thus far indicate that the conference was a success.

Cochrane SA staff published 54 published journal articles during the financial year.

Cochrane SA staff facilitated a number of capacity development initiatives. These included a workshop on Evidence-based health care and Cochrane at the National Health Institute (INS) in Maputo, Mozambique; lectures to medical students at Stellenbosch University and the University of Cape Town; nine systematic review methods webinars, each session attended by 40-100 participants from all over Africa; and three workshops on evidence-based health care and Cochrane for journalists, researchers and International Educational Exchange (CIEE) students.

Cochrane SA staff contributed in various for a to science and policy at international (through membership of communities such as the WHO International Clinical Trials Registry Platform Advisory Group; WHO Immunization and Vaccine-related Implementation Research Advisory Committee; WHO Strategic Advisory Group of Experts on Immunisation (SAGE); WHO SAGE Working Group on Ebola Vaccines and Vaccination) and national levels (e.g. National Essential Medicines List Committee; HIV Adult Advisory Committee of the Western Cape; National Advisory Group on Immunisation)

Twenty-six post graduate students received supervision from Cochrane SA staff. Two of these students who were supported by Cochrane SA received the International Society for Vaccines (ISV) Congress 2018 Low and Middle Income Countries Award in Atlanta, USA.

The Pan African Clinical Trials Registry (PACTR) <u>www.pactr.org</u>, a regional register of clinical trials conducted in Africa, which is hosted at Cochrane SA was redeveloped to provide a more user-friendly, easy to navigate website for researchers, policy-makers, funders and the public.

The South African Guidelines Excellence project (SAGE), a SAMRC Flagship Award funded project presented its final results at a public session in April 2018. The aim of this project was to consolidate methods and training for better clinical practice guidelines development, implementation and use in South Africa.
