# **Evidence to Decision (EtD) Guideline Panel Simulation**

## **Objectives**

This workshop is a simulation of a clinical guidelines meeting and requires participants to role-play. The workshop covers five key learning objectives. These are:

- Guideline panel composition, roles, and managing conflicts of interest
- Key factors determining overall quality of evidence in a GRADE Evidence Profile
- The GRADE Evidence-to-Decision Framework to inform guideline panel discussions
- Formulation of a recommendation
- Implications of the strength of a recommendation

#### **Brief description of content**

This workshop is relevant for policy-makers, health professionals, clinical researchers, consumers and other stakeholders who are involved in decision-making processes regarding choice of healthcare interventions. The workshop is most suitable for individuals who have a thorough prior understanding of systematic reviews and appraisal of evidence quality.

This face-to-face workshop is delivered over a half-day and requires role-play by both the facilitator and the participants. There are no formal pre-course activities. However, participants will be contacted prior to the workshop and provided with a brief description of the roles they are to play during the conduct of the simulated guidelines meeting. Two participants will be asked to chair the guideline meeting and guided appropriately. The workshop is fun, engaging and provides participants with the experience of being part of a guideline panel discussion based on a real-life World Health Organization example.
